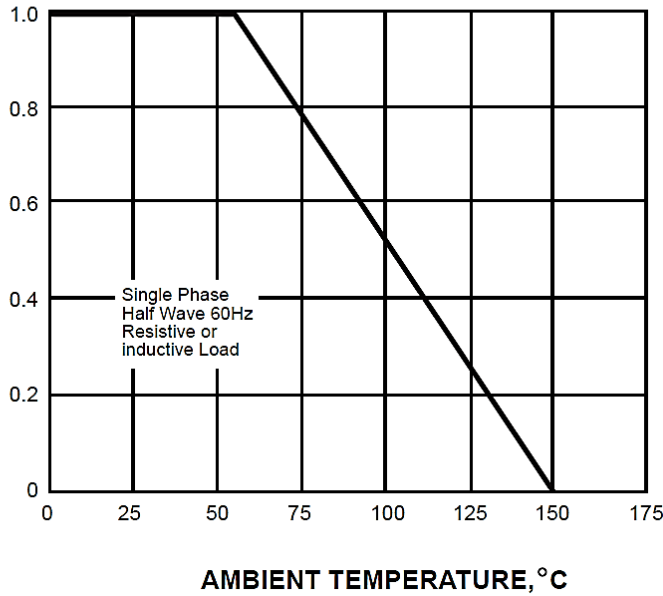

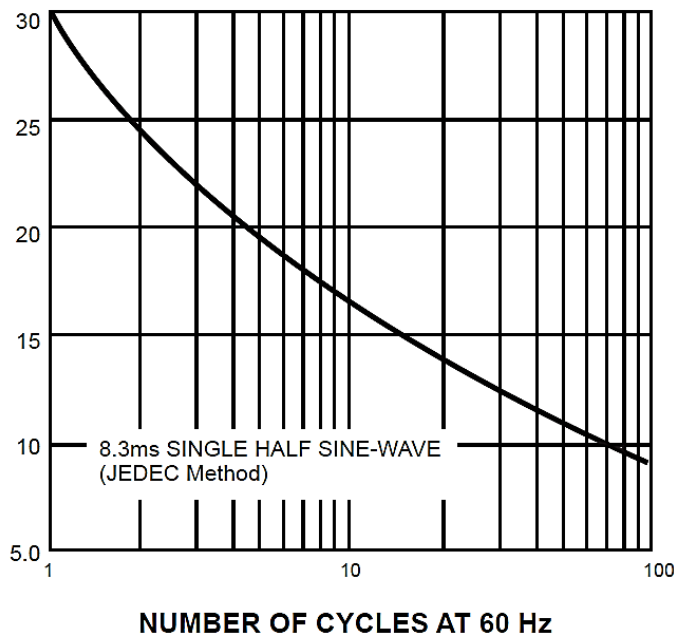

AMPERES**

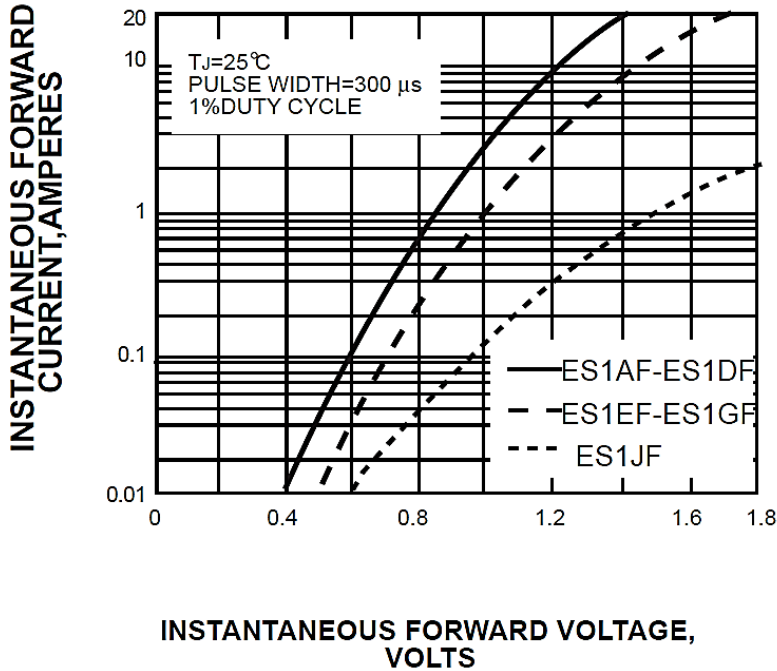
**FIG. 2-MAXIMUM NON-REPETITIVE PEAK FORWARD SURGE CURRENT**



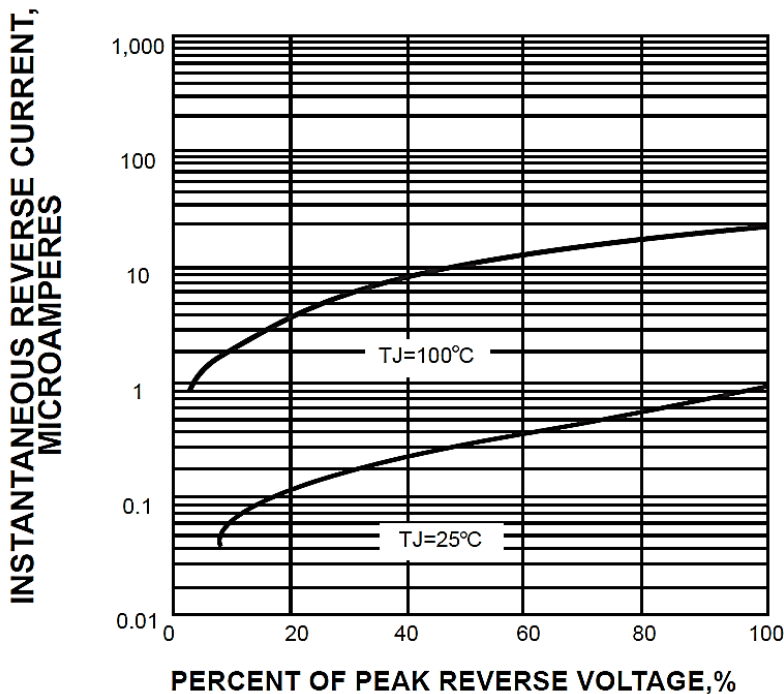

**FIG. 4-TYPICAL REVERSE CHARACTERISTICS**

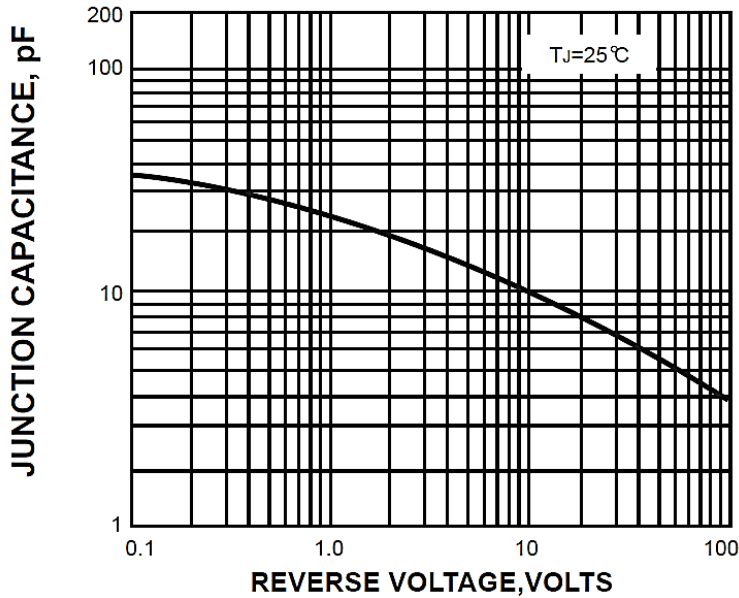




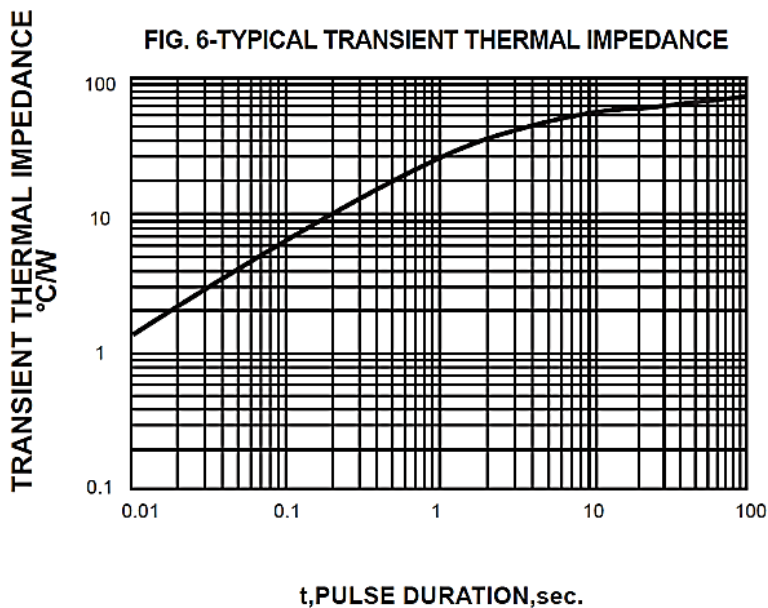

**FIG. 5-TYPICAL JUNCTION CAPACITANCE**

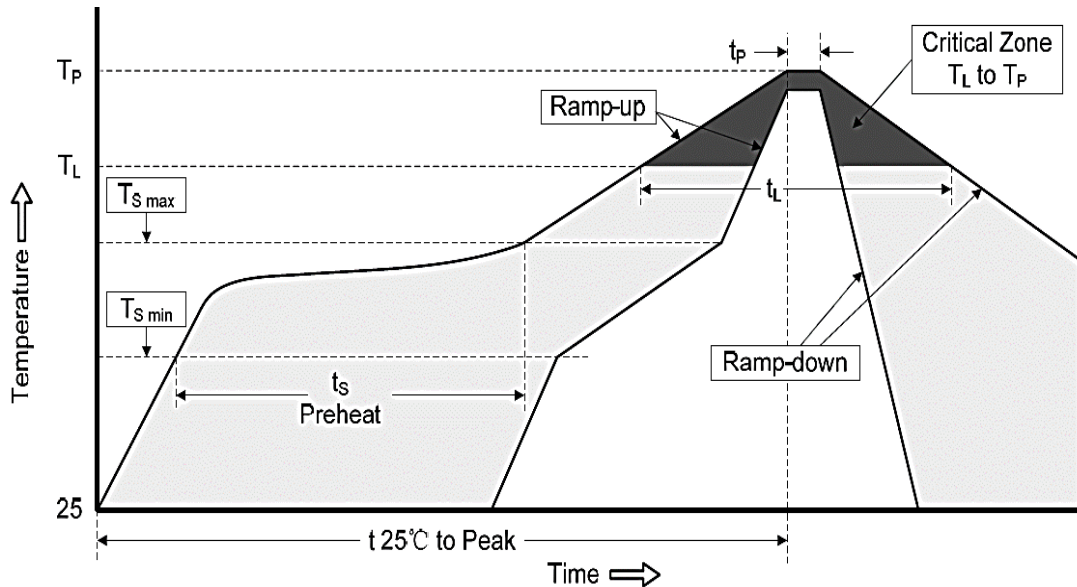


**FIG. 6-TYPICAL TRANSIENT THERMAL IMPEDANCE**
