Figure 1. Reverse Recovery Time Characteristic And Test Circuit Diagram





Figure 2. Maximum Average Forward Current Rating

Figure 3. Typical Reverse Characteristics



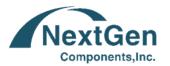


Figure 4. Typical Forward Characteristics

Figure 5. Typical Junction Capacitance






Figure 6. Max. Non-Repetitive Pak Forward Surge Current




