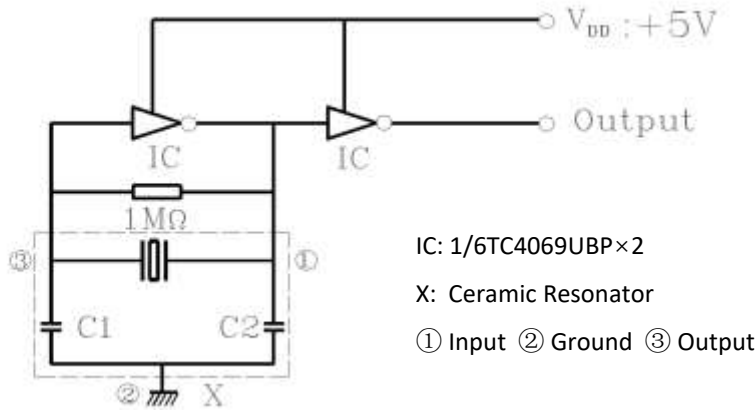

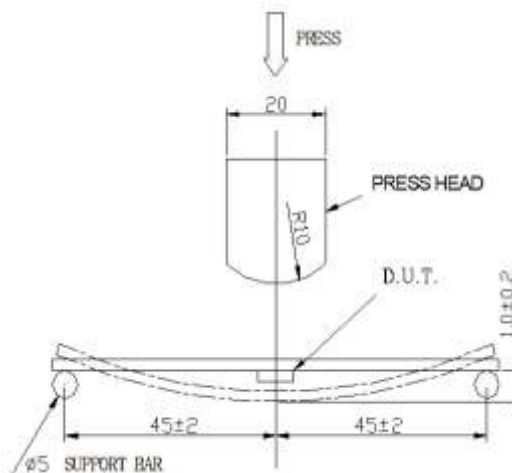

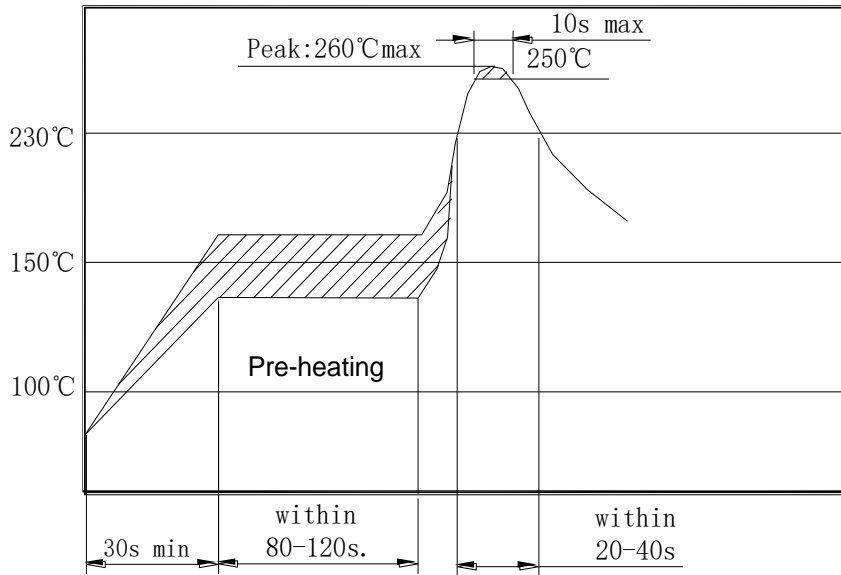

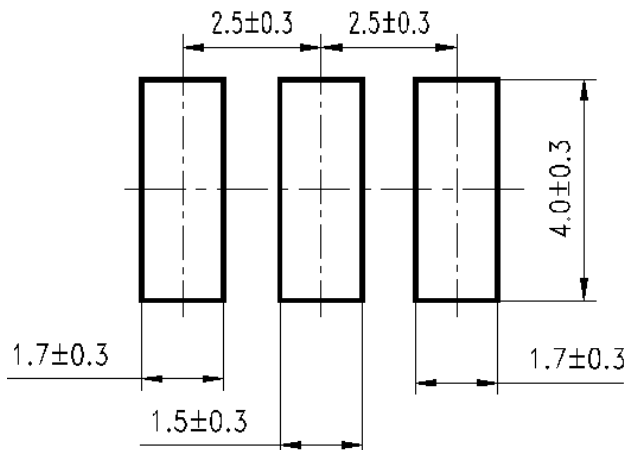




**SUGGESTED REFLOW PROFILE** (For Reference Only)



**RECOMMENDED LAND PATTERN** (Unit: mm)

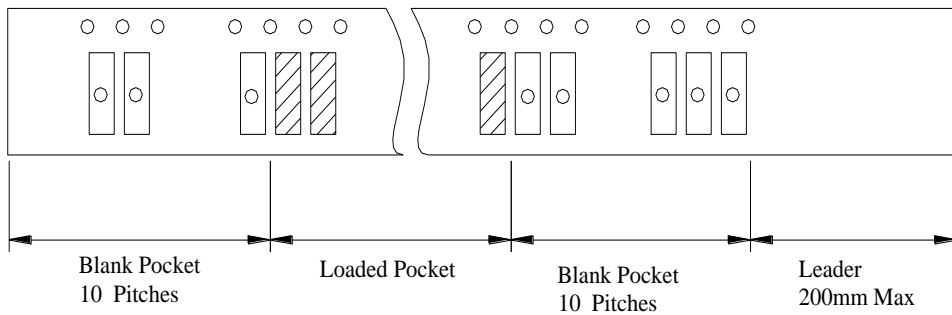

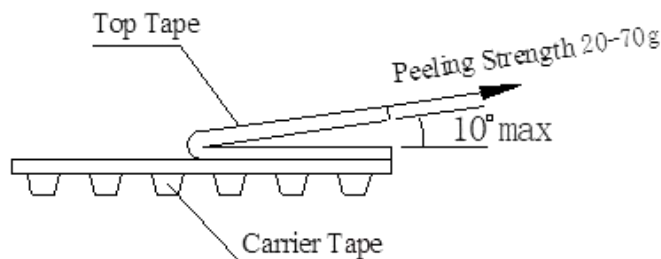
