











RECOMMENDED LAND PATTERN (Unit: mm)





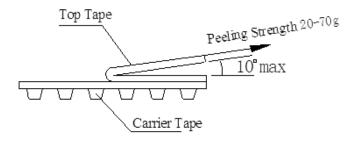
