DESCRIPTION

ESD0501OC is a low-capacitance Transient Voltage Suppressor (TVS) designed to provide electrostatic discharge (ESD) protection for data , control or power lines. With typical capacitance of 10pF only, ESD0501OC is designed to protect parasitic-sensitive systems against over-voltage and over-current transient events. It complies with IEC 61000-4-2 (ESD), Level 4 (\pm 15kV air, \pm 8kV contact discharge), IEC 61000-4-4 (electrical fast transient - EFT) (40A, 5/50 ns), very fast charged device model (CDM) ESD and cable discharge event (CDE), etc. ESD0501OC uses ultra-small DFN1006 package. Each ESD0501OC device can protect one data line. It offers system designers flexibility to protect single data line where space is a premium concern.






Circuit Diagram






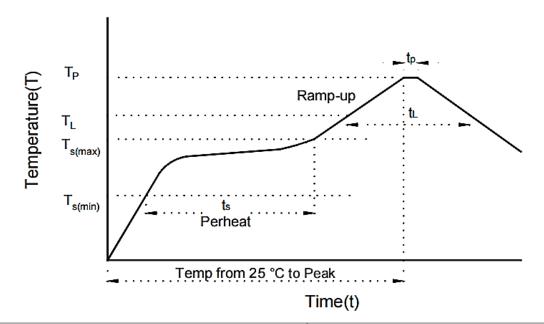


RATINGS AND CHARACTERISTICS CURVES- For Reference Only, Ta=25°C Unless Otherwise Specified.




