






Capacitance Characteristics



Power Derating Curve

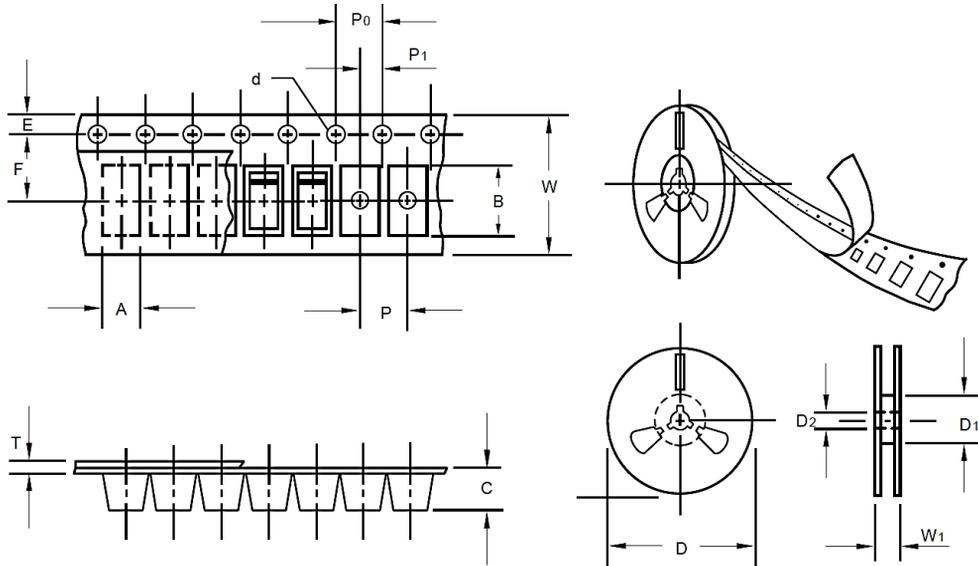
